Notification

G.S.R.- As a consequence of transfer of the scheme of Jan Shikshan Sansthan for Skill Development from Ministry of Human Resource Development (Department of School Education and Literacy) to Ministry of Skill Development and Entrepreneurship and adoption of the Recruitment Rules of Additional Director of Department of School Education & Literacy in the Directorate of Adult Education(Published in the Gazette of India Extraordinary part-II, Section-3, Sub-Section (i) on 23rd May, 2014) by the Ministry of Skill Development & Entrepreneurship and except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules in exercise of the powers conferred by the proviso to article 309 of the Constitution regulating the method of recruitment to the post of Director in the Directorate of Jan Shikshan Sansthan, Ministry of Skill Development & Entrepreneurship in supersession of the Notification dated 23rd May, 2014 cited supra, namely :-

1. Short title and commencement.-(1) These rules may be called, the Directorate of Jan Shikshan Sansthan, Ministry of Skill Development & Entrepreneurship, Director(Group 'A'), Recruitment Rules, 2020.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Application:-These rules shall be applicable to the post specified in the Schedule annexed to these rules.

3. Number of post, classification,-The number of post, its classification, pay level in the pay matrix attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

4. Method of recruitment, age limit, qualifications, etc. - the method of recruitment to the said post, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the aforesaid Schedule.

5. Disqualification.- No person,-

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied, that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in

consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving.-Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, the Ex-servicemen and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.
