OFFICE MEMORANDUM

**Subject: In-principle approval of allocation of training target under Recognition of Prior Learning (RPL) category of PMKVY 3.0 (2020-21) -reg.**

The undersigned is directed to convey the in-principle approval of Competent Authority (MSDE) with regard to allocation of target under RPL category of PMKVY 3.0 (2020-21) is as under :

2. Total RPL target of the scheme (5.80 Lakh) has been divided approximately in the ratio of 75:25 between Centrally Sponsored Centrally Managed (CSCM) (4,33,200) and Centrally Sponsored State Managed (CSSM)(1,46,800). The training target under the scheme has been done district-wise as per target allocation methodology given at **Annexure**.

3. Based on the above, the allocation of RPL targets under both the component of PMKVY 3.0 (2020-21) is given as under:

- a) **Centrally Sponsored Centrally Managed (CSCM) component of PMKVY 3.0 (2020-21):** The CSCM component of PMKVY 3.0 will be implemented by National Skill Development Corporation (NSDC) with the active support of District Skill Committees (DSCs). Target allocation will be done to every state at the rate of 200 for each district under **Phase-I**. Thus 1,46,800 targets are reserved for states/districts under RPL CSCM out of total 4,33,200. A Request for Proposal (RFP)/ direct allocation (mainly to SSCs and govt schemes/ departments) will be done for the balance 2,86,400 targets in CSCM by NSDC under **Phase-2**. Details are mentioned in **Annexure**.
- b) **Centrally Sponsored State Managed (CSSM) component of PMKVY 3.0 (2020-21):** The CSSM component of PMKVY 3.0 will be implemented by State Skill Development Mission (SSDM) with the active support of District Skill Committees (DSCs). Target allocation will be done to every state at the rate of 200 for each district. Thus 1,46,800 (~25%) targets are reserved for states under RPL CSSM. Details are mentioned in **Annexure**.

4. In view of above, NSDC and SSDMs are directed to commence the training of candidate in consultation with District Administrations (DSCs) latest by 15<sup>th</sup> January, 2021. Further, DSC with support of NSDC/SSDMs are directed to start the process of mobilization of candidates, 1.5 times the training target, for early commencement of training.

5. This issues with the approval of Competent Authority (MSDE).

**Target Allocation Methodology under Recognition of Prior Learning (RPL) Component in PMKVY 3.0 for both the components are given below:**

**1. Overview of Target Allocation Methodology:**

Total PMKVY 3.0 RPL targets are 5.80 lakhs and the budget is approximately Rs. 167.5 crores. The total targets will be divided in the ratio of 75:25 between the central and state components. 15% targets can be with Bridge (65,250) which will be applicable to RPL Type 1 and 2.

2. The Bridge course will be restricted to 15% of candidates at the rate of INR 2,958 per candidate/ 68 hours. More candidates can be accommodated with lesser number of Bridge hours, subject to the ceiling calculated at the rate of INR 2,958 for 15% candidates.

**3. Project Type Categorization:**

RPL shall be approved across following 5 **different types** to encourage diversity in type of beneficiaries, geographies involved and method of conduct.

- RPL Type-1 Camps:** This is proposed to be conducted for target beneficiaries in a location where workers of a sector are consolidated (such as industrial and/ or traditional skill clusters). This type can have a Bridge component.
- RPL Type 2-Employer Premises:** This type of RPL is conducted on site at the employer's premises for industrial employees. This type can have a Bridge component.
- RPL Type 3-RPL by Demand –**This type of RPL will be executed at PMKK/ PMKVY Centers. Under RPL CSCM two modes of mobilization: (i) direct candidate demand collected through Demand Aggregation Portal (DAP) and allocated to designated PMKK centres (ii) The district demand under RPL CSCM will also be taken up under this type of RPL.
- RPL Type 4-RPL with Best-in-Class Employers (BICE)-**Large Corporations/industry and Medium Scale Enterprises: This type of RPL involves Best-in-Class Employers in both large and medium enterprises that are selected as per SSC criteria. Employees of best-in-class employers are certified by 'Employer-Assessor'.
- RPL Type 5-Online RPL:** This type of demand-based RPL is open to all skill seekers who wish to take an online exam and get certified. Proctoring is executed through video links and other tools without any physical interface.

#### 4. RPL under Centrally Sponsored Centrally Managed (CSCM) component):

- a) A target allocation will be done to every state at the rate of 200 for each district. Thus 1,46,800 targets are reserved for states/ districts under RPL CSCM out of total 4,33,200.
- b) District can select a job role for the allocated 200 targets and inform NSDC. The targets will be allocated to the PMKK/ PMKVY centre in the district allocated STT targets by direct allocation.
- c) An RFP/ direct allocation (mainly to SSCs and and govt schemes/ departments) will be done for the balance 2,86,400 targets in CSCM by NSDC.
- d) The table below gives the initial distribution of 4,33,200 targets under CSCM considering project and district demands. The cost of RPL Type 1 and 2 is more than the budgeted INR 2,441 per RPL in PMKVY 3.0 while the cost of Type 3, 4 and 5 is below the budgeted cost. Thus, an optimal mix of all types is imperative to stay within the overall RPL budget. The numbers have been arrived at by cost and target maximisation.
- e) The targets allocated directly to districts (i.e. 200 per district) for implementation by PMKK/ PMKVY centres will be done under Type 3.

#### 5. RPL under Centrally Sponsored State Managed (CSSM) component):

- a) Having met the district level aspirations through CSCM, the states/ SSDMs can use the RPL CSSM targets gainfully by creating RPL projects at the state level.
- b) A target allocation will be done to every state at the rate of 200 for each district. Thus 1,46,800 (~25%) targets are reserved for states under RPL CSSM. Please see Annexure I for state RPL CSSM allocation.
- c) SSDMs should create and evaluate RPL projects in Type 1, 2 and 3.

- d) If so desired or in the event of lack of capacity, states may distribute targets to each district and let the district select a job role. Thereafter states can select a PIA/ TP / PMKVY centre to execute the RPL in each district.
- e) All the approvals will be done by state empowered committee. Projects with Bridge course (restricted to 15%) will be approved at MSDE
